that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year.

to-wit: Beginning at the NN corner of said tract 30 and running thence S. 0° 48'
W. 740.76 ft. to the SN corner of said tract 30; thence S. 66° 48' E. along the
S. line of said tract 30, a distance of 361.23 ft. to corner; thence N. 51° 47' E.
along the S. line of said tract 31, a distance of 277.4 ft. to the SE corner of
said tract 31; thence N. 9° 13½' E. 748 ft. to a point in the center of the County
Road and in the North line of said tract 31; thence S. 89° W. along the N. line
of said tract 30 and 31 and center line of County Road 660 ft. to the beginning.
