under Permit No. 21613 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 16. 1952.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 4 (NE<sup>1</sup> NE<sup>1</sup>), Section 35. Township 5 South. Range 6 West. W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year.

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.13 acres in Lot 3 (NE4 NE4)
0.20 acres in Lot 4 (NE4 NE4)
Section 35
Township 5 South, Range 6 West, W. M.

Land on which water is to be used is a part of that described as follows:

Beg. at low water mark on the N. bank of the Yamhill River 100 ft. E. from the SE corner of the A. B. Faulconer D.L.C. No. 43, thence N. 10° E. 2.0 chs to the S. line of the county road; thence N.  $80\frac{1}{2}$ ° E. 6.23 chs; thence S. 63° E. 5.77 chs.; thence S. 2.0 chs. to low water mark on the N. bank of said Yamhill River; thence up the said stream following low water mark to the place of beg. Save and except 100 ft. off the W. end. Also save and except tract of approximately 1.79 acres on E. side.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
