CERTIFICATE OF WATER RIGHT

This Is to Certify, That JOE STADELMAN

of Route 1, Cornelius , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream and reservoir constructed under Application No. R-28496, Permit No. R-1525 at Fork of Dairy Creek for the purpose of irrigation

under Permit No. 22420 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 22, 1952

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.03 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in-the Lot 2 (SW4SW4) Section 23, Township 2 North, Range 3 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-1525,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.0 acres in Lot 2 (SW\(\frac{1}{2}\)SW\(\frac{1}{4}\))
Section 23
Township 2 North, Range 3 West, W. M.

Land on which water is to be used is part of that described as follows:

Beg. at the SW cor. of said Lot 2, Sec. 23, said cor. being N 12.25 chs. more or less from the SW cor. of Sec. 23, T 2 N, R 3 W, W.M., thence on the N line of the F. Dobbins DLC Easterly 20 chs. more or less to the SE cor. of said Lot 2, thence N 7.75 chs. more or less; thence Westerly 20 chs. more or less to the W line of Sec. 23; thence on sec. line S 7.75 chs. more or less to the place of beg.

The NW15W1 of Sec. 23, T 2 N, R 3 W, W.M., Washington County.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
