a tributary of Tualatin River

irrigation

under Permit No. 16039 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 26, 1944

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NWISWI. as projected within Hart DLC \$60. Section 12, Township 1 South, Range 1 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands; shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 acre feet per acre for each acre irrigated during the irrigation season of each year.

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.75 acres in the NW4SW4, as projected within Hart DLC #60 Section 12

Township 1 South, Range 1 West, W.M. land on which water is to be used is part of that described as follows: Beg. at the most W/ly cor. of that certain tract of land conveyed to Geo. W. DesBrisay by deed recorded in Book 124, Page 254, Deed Records of Wash. County, Oreg.; th. S 78° 19' B along the S line of the said DesBrisay tract 279.7 ft. to the true point of beg. of the tract to be described: Th. N 5° 42' W 239.3 ft. to the center of Old Canyon Rd. Hwy; th. & 35 27 E tracing the center line of said Old Canyon Rd. Hwy: 240.5 ft. to a point path S 45° 42° B 343.6 ft. to an iron pipe; th. S 45° 31' W 99.6 ft. to an iron pipe; (th. N 78° 19' W along the S line of the said DeeBrisay tract 447.5 ft. to the true point of beg. of the tract herein described; subject to the rights of the public is and to that portion thereof included within the boundaries of said Old Conyon Road Highway.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
