CERTIFICATE OF WATER RIGHT

This Is to Certify, That **EDWARD H. SAHLFELD**

of **Route 3, Hillsboro**, State of **Oregon**, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of **McKay Creek** a tributary of **Tualatin River** for the purpose of irrigation

under Permit No. **19199** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **December 19, 1949**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **1.0 cubic foot per second**

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the **NE 1/4, Section 25, Township 1 North, Range 3 West, W.M.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **2 1/2** acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 18.1 acres in the **SW 1/4**, as projected within **Wooley DLC #49**
- 3.8 acres in Lot 2 (**SW 1/4**)
- 7.8 acres in the **SE 1/4**
- 28.3 acres in the **NE 1/4**
- 5.4 acres in lot 3 (**NW 1/4**)
- 19.9 acres in the **NW 1/4**, as projected within **Wooley DLC #49**

6.5 acres in the **SE 1/4**, as projected within **Wooley DLC #49**

6.0 acres in the **NE 1/4**, as projected within **Wooley DLC #49**

Township 1 North, Section 25, Range 3 West, W.M.

Land on which water is to be used is part of that described as follows: Beg. 20 chs N. of the SE cor. of the **Wooley DLC** in **T 1 N, R 3 W, W.M., Wash. County, Ore.** running th. W 20 chs; th. N/ly along County Rd. #1520; th. S 20.70 chs to a point on the E line of the **Wooley DLC** 45.18 chs N. of the SE cor. of said Claim; th. E/ly & S/ly following the County Rd. to the center of **McKay Cr.**; th. S/ly following the center of **McKay Cr.** with all of its meanderings thereof to the S line of the **NW 1/4** of **Sec. 25, T 1 N, R 3 W, W.M.**, th. W to the SW cor. of the **NW 1/4**; th. W/ly 20 chs to the SW cor. of the **NE 1/4** of said **Sec. 25**; th. N 412.0 ft to an iron; th. N 89° 43' W 368.5 ft. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
