## CERTIFICATE OF WATER RIGHT

of Route 1. Box 152, Scappoose , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Scappoose Creek for the purpose of irrigation under Permit No. 21694 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 8. 1952

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.06 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NWANWA. Section 13. Township 3 North. Range 2 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year.

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

4.6 acres in the NW#NW# Section 13 Township 3 North, Range 2 West, W.M.

Land on which water is to be used is part of that described as follows:

Beg. at the NW cor. of the Jesse Miles DLC in Sec. 12, T 3 N, R 2 W, W.M., Columbia County, Oreg; th. S 20° 56' W on the W line of said Miles DLC 643.34 ft. to a point on the N line of Sec. 13, T 3 N, R 2 W, being the point of beg. of tract to be described; running th. S 20° 56' W on the W line of said Miles DLC 392.09 ft; th. W. 567.92 ft; th. N 6° 14' E 192.15 ft; th. N 15° 14' E 105.17 ft; th. N 10° 14' E 70.72 ft. to a point in the N line of said Sec. 13; th. N 89° 38' E on said N line of Sec. 13, 646.96 ft. to the place of beg., reserving, however, from above described tract, a 25 ft. strip along the W side there of for public rd., all in Sec. 13, T 3 N, R 2 W, W.M., Columbia County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
