CERTIFICATE OF WATER RIGHT

This Is to Certify, That CLAIRE A. & MARJORIE E. RICHARDSON

of 217 N 1st St., Hillsboro, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a spring a tributary of irrigation for the purpose of irrigation under Permit No. 19699 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 11, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.025 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW 1/4 SE 1/4, as projected within Wilcox DLC #69, Section 36, Township 1 North, Range 3 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 0.37 acres in the NW 1/4 SE 1/4, as projected within Wilcox DLC #69
1.82 acres in the SW 1/4 SE 1/4, as projected within Wilcox DLC #69
Section 36

Township 1 North, Range 3 West, W.M.

Land on which water is to be used is part of that described as follows:

Parcel 1 - Beg. 24 rods S of the NW cor of Block 10, Hillsboro Garden Tracts, for a beg. point, th. S along the W line of Block 10 to the N line of Main St. extended; Hillsboro, Ore.; th. E along the N line of Main St. 10 rods; th. N parallel with the W line of Block 10 to a point 24 rods S of the N line of Block 10; th. W. parallel with the N line of said Block 10 to place of beg. Parcel 2 - Beg. at the SE cor. of the above tract, th. E along the N line of Main St. extended 97.5 ft. to a point 150 ft. W of the SE cor. of that certain tract described in Deed Book 219, PP. 107 Deed Records of Wash. County, Ore.; th. N parallel with W line of Block 10, Hillsboro Garden Tracts 176 ft; th. W parallel with the N line of Main St. as extended 97.5 ft. to the E line of first tract above described; th. S along the E line of said tract 176 ft. to the place of beg. Recorded in Book 259, Page 521, Wash. County Deed Records.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
