## CERTIFICATE OF WATER RIGHT

This Is to Certify, That MR. AND MRS. GEORGE U. BENZ

of 16550 SW 113th Ave., Tigard , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed creek

a tributary of Tualatin River

for the purpose of

irrigation

under Permit No. 19762 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 10, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the  $SW_{\tau}^{1}NE_{\tau}^{1}$ , Section 15, Township 2 South, Range 1 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year.

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.8 acres in the SW4NE4 Section 15

Township 2 South , Range 1 West, W.M.

Land on which water is to be used is part of that described as follows: All that part of Lot 21 in & of Willow Brook Farm a duly recorded subdivision in Sec. 15, T 2 S, R 1 W, W.M., in Wash. County, Oreg., & more particularly described as follows, to-wit: Beg. at the NE cor. of said Lot 21 & running thence S along the E line of Lot 21 a distance of 294.2 ft. to an iron pipe; th. N 85° 27' W 595.1 ft. to an iron pipe on the W line of lot; th. N 248.0 ft. to the NW cor. of lot 21; th. E along the N line of lot 21 to the place of beg., being the said NE cor. of lot 21, & all of that part of lot 22 in Willow-Brook Farm Subdivision described as follows: Beg. at the SE cor. of lot 22 & running th. W along the S line of lot 22 to the SW cor. of lot 22 & running th. N. along the W line of lot 22 a distance of 130.3 ft. to a point on the W line of lot 22 from which an iron pipe bears S 77° 32' E 20.5 ft; th. S 77° 32' E 607.8 ft. to the said place of beg., being the SE cor. of said lot 22.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
