CERTIFICATE OF WATER RIGHT

This Is to Certify, That HAROLD E. & MARTHA HORTON

of Route 3, Box 695, Oregon City, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Abernathy Creek a tributary of Willamette River for the purpose of irrigation under Permit No. 19971 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 21, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.24 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ NE $\frac{1}{4}$, as projected within Walker DLC #43, Section 3, Township 3 South, Range 2 East, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows: 6.4 acres in the SE $\frac{1}{4}$ NE $\frac{1}{4}$, as projected within Walker DLC #43
11.4 acres in the SW $\frac{1}{4}$ NE $\frac{1}{4}$, as projected within Walker DLC #43
1.4 acres in the SW $\frac{1}{4}$ NE $\frac{1}{4}$, as projected within S. Francis DLC #42
Section 3
Township 3 South, Range 2 East, W.M.

Land on which water is to be used is part of that described as follows: Beg. at a point on claim line which point is N 1° E 16.23 chs. from the SW cor. of the Charles Walker DLC #43; th. N 79° 30' W 2.75 chs; th. N 1° E 10.05 chs. the center of County Rd; Th. N 79° E 2.86 chs; th. N 30° E 3.14 chs; th. N. 85° 30' E 8.25 chs. to center of Abernathy Cr; th. following the meanders thereof on center as follows: N 2.0 chs; th. E 1.50 chs; th. S 1° E 5.75 chs; th. S 85° E 1.27 chs; th. N 68° E 2.0 chs; th. S 1° E 6.05 chs; th. S 10° W 1.15 chs; th. N 42° 30' W 1.31 chs; th. N 85° W 1.40 chs; th. S 73° W 1.32 chs; th. S 46° 45' W 2.16 chs; th. S 10° W 0.54 chs; th. S 10° E 3.10 chs. to center of Bridge; th. on wagon rd. as follows: S 56° W 1.65 chs; th. N 66° W 3.45 chs; th. N 37° W 1.0 chs.; thence N 83° W 2.50 chs; th. S 85° 40' W 2.15 chs; thence S 0.80 chs; thence N 84° 55' W 0.22 chs. to place of beg.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
