CERTIFICATE OF WATER RIGHT

This Is to Certify, That LESTER & MARGARET SUSBAUER

of Rt. 2, Box 394, Forest Grove, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of West Dairy Creek a tributary of Dairy Creek a tributary of Tualatin River for the purpose of irrigation under Permit No. 20968 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 5, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.40 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 12, Township 1 North, Range 4 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.3 acres in the NW $\frac{1}{4}$ NE $\frac{1}{4}$
7.5 acres in the NE $\frac{1}{4}$ NW $\frac{1}{4}$
3.8 acres in the NW $\frac{1}{4}$ NW $\frac{1}{4}$
3.6 acres in the SW $\frac{1}{4}$ NW $\frac{1}{4}$
34.8 acres in the SE $\frac{1}{4}$ NW $\frac{1}{4}$
12.6 acres in the SW $\frac{1}{4}$ NE $\frac{1}{4}$

Section 12

Township 1 North, Range 4 West, W.M.

Land on which water is to be used is part of that described as follows:

That part of Sec. 12, T.1 N, R.4 W, W.M. bounded & described as follows: Beg. at an iron set on the W line of said Sec. 12, 16 chs. S of the NW Cor. of said Sec. 12, & running th. S on said sec. line 9.52 chs; th. S 39° E 13 chs; th. S 6° 0' W 4.36 chs. to a point 7.71 chs. N 89° 19' E from the $\frac{1}{4}$ sec. cor. on the W line of said Sec. 12, th. N 89° 19' E 39.765 chs. to an iron; th. N 0°05' W 40.11 chs to N line of sec. 12; th. S 89° 13' W 0.50 chs to an iron; th. S 0°05' E 16 chs to an iron th. S 79° 12' W 0.50 chs to the place of beg.
The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
