CERTIFICATE OF WATER RIGHT

This Is to Certify, That D. H. MERRITT

of Box 25. Days Creek , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Days Creek

a tributary of South Umpqua River for the purpose of irrigation

under Permit No. 19807 of the State Engineer; and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 28, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes

aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.03 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the NELSWL, as projected within Thomas DLC #48,
Section 10, Township 30 South, Range 4 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre; or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year.

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.6 acres in the NE¹/₂SW¹/₄, as projected within Thomas DLC #48
Section 10
Township 30 South, Range 4 West, W.M.

Land on which water is to be used is part of that described as follows: Beg. at a 1" iron pipe on the W boundary of the Days Creek County Road as now located, said point being 92.0 ft. W of the inner cor. of DLC #48, running th. W 760.9 ft. to a 1" iron pipe; th. S 31° 23' 30" E, 500.8 ft. to a 1" iron pipe in the fence line marking the W boundary of the Days Cr. County Rd.; th. along said fence line N 46° 0° E, 142.5 ft; th. N 32° 05' 30" E, 43.3 ft; th. N 44° 48' 40" E 159.0 ft; th. N 54° 20' 40" E, 87.3 ft; th. N 56° 13' 00" E 230.5 ft. to the place of beg., situated in Sec. 10. T. 30 S., R. 4 W., W.M., Douglas County, Oregon, containing 3.48 acres.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
