CERTIFICATE OF WATER RIGHT

This Is to Certify, That HENRY FRISON

of Route 1, Box 291, Tigard, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Spring Creek & Tualatin River a tributary of Tualatin River for the purpose of irrigation under Permit No. 20690 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 24, 1951

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.32 cubic foot per second, being 0.106 c.f.s. from creek & 0.214 c.f.s. from river

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 3 (SE $\frac{1}{4}$ NW $\frac{1}{4}$), & NE $\frac{1}{4}$ NW $\frac{1}{4}$ & SE $\frac{1}{4}$ NW $\frac{1}{4}$, as projected within Richardson DLC #44, Section 14, Township 2 South, Range 1 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 17.3 acres in the NE $\frac{1}{4}$ NW $\frac{1}{4}$, as projected within Richardson DLC No. 44
- 8.0 acres in the SE $\frac{1}{4}$ NW $\frac{1}{4}$, as projected within Richardson DLC No. 44
- 0.4 acres in Lot 3 (SE $\frac{1}{4}$ NW $\frac{1}{4}$)

Section 14

Township 2 South, Range 1 West, W.M.

Land on which water is to be used is part of that described as follows: Commencing on the Sec. line running between Sec. 11 & 14, T 2 S, R 1 W, W.M., 20 chs E of the NW Cor. of Sec. 14, at the SW cor. of the Joseph Sax's land, th. E 10 chs, th. S 30 chs. to the S line of the Col. Richardson DLC; th. W on said line 10 chs; th. N 30 chs. to the place of beg. Containing 30 acres more or less. Said land being a part of the W $\frac{1}{2}$ of the Solomon & Elizabeth Richardson DLC Not. #1456 surveyed and designated as Claim #44 situated in Sec. 14, T 2 S, R 1 W, W.M. in Wash. County, State of Oregon, save and except a strip of land 16 ft. wide off the N end of the above described 30 acre tract which said 16 ft. is reserved for road purposes.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
