CERTIFICATE OF WATER RIGHT

(For rights perfected under original, enlargement or secondary permits)

This is to Certify, That WOLF RUN WATER USERS ASSOCIATION

of Dufur, State of Oregon, has made proof to the satisfaction of the STATE WATER BOARD of Oregon, of a right to the use of the waters of Tamarack Creek, Springs & Gulch, a tributary of Columbia River

domestic and stock use, for the purpose of the irrigation of 65 acres of land,

under Permit Nos 92 & 93 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon and duly confirmed by order of the STATE WATER BOARD of Oregon, made and entered

of record in the Record of Proceedings of said Board, at Salem, in Volume 1

at page 320, on the 15th day of May, 1919; that the priority of

the right hereby confirmed dates from May 3, 1909; that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not

exceed 1.16 cubic feet per second.

A description of the lands under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows: 15 acres in the Southwest quarter of Southeast quarter; 15 acres in the Southeast quarter of Southeast quarter; 10 acres in the Northeast quarter of Southeast quarter; 10 acres in the Northwest quarter of Southeast quarter and 15 acres in the Southeast quarter of Southwest quarter of Section Thirty; 5 acres in the Southeast quarter of Northwest quarter and 15 acres in the Northeast quarter of Southwest quarter of Section Twenty-nine, Township One South, Range Thirteen East of Willamette Meridian, in Wasco County, Oregon.

The use for irrigation purposes hereunder shall be limited to one-eightieth of one cubic foot per second for each acre irrigated, or its equivalent in case of rotation; balance for domestic and stock use. The use for irrigation purposes shall conform to any reasonable rotation system ordered by the proper State Officer.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.

Rights to the use of water for power purposes are limited to a period of forty years from the date of priority of the right, as herein set forth, subject to a preference right of renewal under the laws existing at the date of the expiration of the right for power purposes, as hereby confirmed and limited.
