CERTIFICATE OF WATER RIGHT

This Is to Certify, That SISTERS OF ST. MARY

of 4440 SW 148 Avenue, Beaverton, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Beaverton Creek a tributary of Rock Creek for the purpose of irrigation under Permit No. 21599 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 9, 1952

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.06 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 4 (NE $\frac{1}{4}$ SE $\frac{1}{4}$), Section 8, Township 1 South, Range 1 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year.

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.8 acres in Lot 4 (SE $\frac{1}{4}$ SE $\frac{1}{4}$)
Section 8
2.5 acres in Lot 2 (SW $\frac{1}{4}$ SW $\frac{1}{4}$)
Section 9
Township 1 South, Range 1 West, W. M.

Land on which water is to be used is to be used is part of that described as follows:

Beg. at the SW cor. of the G. W. Elliott DLC #42, T 1 S, R 1 W, Th. on the E line of the John Elliott DLC #41, S 21° 30' W 20.35 chs. to the NW cor. of a 10.0 acre tract sold by the above named Grantors, th. S 81° 30' E 17.77 chs. to the NE cor. of a tract theretofore conveyed by the above Grantors to the above named Grantees th. S 10.04 chs., th. S 81° 30' E 14.12 chs. to the SW cor. of a 5.0 acre tract heretofore conveyed by said Grantors to Bloom, th. N. 25.30 chs. to the S line of said Claim #42, th. N 69° 30' W 21.39 chs. to the place of beg., being part of section right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
