CERTIFICATE OF WATER RIGHT

This Is to Certify, That EARL L. HORNING

of Route 2, Box 865, Beaverton, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Beaverton Creek a tributary of Rock Creek for the purpose of irrigation

under Permit No. 22050 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 22, 1953

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.12 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ NE $\frac{1}{4}$, as projected within Wm. H. Bennett DLC #40, Section 2, Township 1 South, Range 2 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year.

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

8.5 acres in the SE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within Bennett DLC #47 Section 35 Township 1 North, Range 2 West, W.M.

0.7 acres in the NE $\frac{1}{4}$ NE $\frac{1}{4}$, as projected within Bennett DLC #40 Section 2 Township 1 South, Range 2 West, W.M.

Land on which water is to be used is part of that described as follows: Being a part of the Wm. H. Bennett DLC #40, in T 1 S, R 2 W, W.M., Beg. in the N line of said claim at a stone set for the NE cor. of the land of John & Wm. Overroeder 14.26 chs. from the NE cor. of said claim #47, T 1 N, R 2 W, W.M., & running th. S 1° 48' E on said Overroeder's E line 24.99 chs. to the S line of said claim #40, T 1 S, R 2 W, W.M., at a point 14.36 chs. from the SE cor. of said claim; thence S 89° 28' E on said line 4.793 chs; th. N 1° 48' W 25.06 chs. to the N line of said claim #47; th. W on said claim line 4.793 chs. to the place of beg.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
