## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That ED S. & ALTA BOWERS

of Route 1, Box 49, Lebanon State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Santiam River

a tributary of Willamette River for the purpose of

irrigation under Permit No. 22044 of the State Engineer, and that said right to the use of said we ters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 20, 1953

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.22 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NELSEL, as projected within G. Klum DLC #39, Section 19, Township 12 South, Range 1 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed ? acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 1.6 acres in the  $NE_{\psi}^{1}SE_{\psi}^{1}$ , as projected within G. Klum DLC #39
- 0.8 acres in the NW4SE4, as projected within G. Klum DLC 139
  3.6 acres in the SW4SE4, as projected within G. Klum DLC 139
- 10.8 acres in the SELSEL, as projected within G. Klum DLC #39 Section 19
- 0.8 acres in the NEINE, as projected within G. Klum DLC #39
- 0.2 acres in the NWANEA, as projected within G. Klum DLC #39 Section 30

Township 12 South, Range 1 West, W.M.

Land on which water is to be used is part of that described as follows: Beg. at a 3/4" iron pipe S 31.85 chs. & E 12.31 chs. from the NW cor. of George W. Klum DLC #39, Not. #2522, in T 12 S, R 1 W; th. E 7.20 chs; th. N parallel with the W line of said Claim 24.70 chs. to the Santiam River; th. down the meanderings of said river NW/ly to a point 12.31 chs. E of the W line of said Claim 39; th. S 29.59 chs. to the place of beg.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
