**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That**            LAWRENCE L. WAIBEL

of    Route 5, Box 160, Hillsboro            , State of    Oregon    , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Tualatin River

a tributary of            Willamette River            for the purpose of irrigation

under Permit No.    22054            of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from    January 26, 1953

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.35 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$  SW $\frac{1}{4}$ , Section 17, Township 1 South, Range 2 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

6.4 acres in Lot 1 (NE $\frac{1}{2}$ NE $\frac{1}{4}$ )  
20.2 acres in the SE $\frac{1}{2}$ NE $\frac{1}{4}$   
1.7 acres in the NE $\frac{1}{4}$ SE $\frac{1}{4}$   
Section 18

Township 1 South, Range 2 West, W.M.

Land on which water is to be used is to be used is part of that described as follows:

Commencing at a point 10 chs. S of the NE cor. of Sec. 18, T 1 S, R 2 W, W.M., said point being in the center of the Hillsboro and Minter Bridge Road at the SE cor. of land sold by Chas. L. Crocker to W. L. Crocker by deed recorded in volume 35, page 153 of Washington County, Oregon, Deed Records; th. running S 0° 14' W 44.25 chs. more or less to the center of the Tualatin River; th. up the center of said river 15.84 chs; th. N 30.61 chs. to a post; th. W to the center of the above described county road; th. along the center of said road E/ly to the place of beg.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
