CERTIFICATE OF WATER RIGHT

This Is to Certify, That LESLIE L. & ANNIE J. GARRISON

of 3623 SE Naef Rd., Milwaukie 22, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream a tributary of Willamette River for the purpose of irrigation under Permit No. 22105 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 10, 1952

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ NE $\frac{1}{4}$, as projected within Rogers DLC #37, Section 13, Township 2 South, Range 1 East, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.50 acres in the NW $\frac{1}{4}$ NE $\frac{1}{4}$, as projected within Rogers DLC #37
 0.25 acres in the SW $\frac{1}{4}$ NE $\frac{1}{4}$, as projected within Rogers DLC #37
 Section 13
 Township 2 South, Range 1 East, W.M.

Land on which water is to be used is to be used is part of that described as follows:

beg. at a point 684.42 ft. E of the intersection of the NW/ly line of the Benoni B. Rogers DLC #37, T 2 S, R 1 E, W.M., with the NE/ly line of the Rinearson & Milwaukie Road commonly known as the River Road, said point of intersection being N 52° E 944.75 ft., more or less from the NW/ly cor. of said DLC on the E/ly bank of the Willamette River; th. along said NW/ly line of said DLC N 52° E 459.92 ft. to the SW/ly line of the right of way of the P.E.P. railway Co., (east side railway); th. S 41° 17' E along said right of way 194.04 ft; th. S 52° W 453.37 ft; th. N to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
