## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That SAM and ANNA SCHULTR

of Rt. 3. Box 91. Lebanon , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed slough and reservoir constructed under App. No. R-28320. Per. No. R-1503 a tributary of Crabtree Creek for the purpose of irrigation

under Permit No. 22356 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dutes from April 14, 1953.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.24 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the  $SW_{*}^{1}$   $SW_{*}^{1}$ , Section 12, Township 11 South, Range 2 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-1503.

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

19.0 acres in the SW<sup>1</sup>/<sub>4</sub> SW<sup>1</sup>/<sub>4</sub>
Section 12
Township 11 South, Range 2 West, W.M.

Land on which water is to be used is part of that described as follows:

Beginning at the SW corner of Sec. 12, T. 11 S., R. 2 W., W.M., in Linn County, Oregon; and running thence easterly of the Sec. line 10.01 chs.; thence northerly parallel with the W. line of Sec. 12 a distance of 20.00 chs., more or less, to the center line of a county road; thence westerly along the center line of said road parallel with the S. line of Sec. 12 a distance of 10.01 chs. to the W. line of said Sec. 12; thence southerly along the W. line of Sec. 12 a distance of 20 chs., more or less, to the place of beginning and containing 20 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
