CERTIFICATE OF WATER RIGHT

This Is to Certify, That CARL MARTIN

of Rt. 1, Box 50-E, Lebanon, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Santiam River a tributary of _____ for the purpose of irrigation under Permit No. 21102 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 18, 1952,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.12 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ SE $\frac{1}{4}$ as projected within Klum DLC #39, Section 19, Township 12 South, Range 1 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year.

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 6.1 acres in the SE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within Klum DLC #39 Section 19
 - 3.3 acres in the NE $\frac{1}{4}$ NE $\frac{1}{4}$, as projected within Klum DLC #39 Section 30
- Township 12 South, Range 1 West, W.M.

Land on which water is to be used is part of that described as follows:
Beginning at a 3/4" iron pipe which is S. 1130.07 ft. and W. 1085.74 ft. from the NE corner of the George W. Klum DLC #39 in T. 12 S., R. 1 W., W.M.; thence N. 75° 08' E. 290.25 ft. to a 3/4" iron pipe; thence S. 52° 52' E. 12.36 ft. to an iron pipe; thence N. 00° 07 $\frac{1}{2}$ ' W. 1393.87 ft. to the S. meander line of the S. Santiam River; thence N. 65° 26' W. 110.71 ft.; thence N. 66° 38' W. 209.66 ft.; thence S. 00° 07 $\frac{1}{2}$ ' E. 1588.25 ft. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
