under Permit No. 21214 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 24, 1952,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.40 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW: NW: as projected within R. Cheadle DLC #55, Section 19, Township 12 South, Range 1 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year.

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.2 acres in the $NW_{4}^{\frac{1}{4}}$ $NW_{4}^{\frac{1}{4}}$, as projected within R. Cheadle DLC #55 30.0 acres in the $SW_{4}^{\frac{1}{4}}$ $NW_{4}^{\frac{1}{4}}$, as projected within R. Cheadle DLC #55

2.1 acres in the SE $^{\frac{1}{4}}$ NW $^{\frac{1}{4}}$, as projected within R. Cheadle DLC #55 Section 19

Township 12 South, Range 1 West, W.M.

Land on which water is to be used is part of that described as follows:

Beginning at a point 20 ft. N. of the N. line and 975 ft. W. of the NE corner of the R. Cheadle DLC #38; thence N. approximately 1305 ft. to the S. line of the South Santiam River; thence Westerly along said S. line of river approximately 395 ft. to a point which is 125 ft. Easterly from the center line of the Mountain States Power Co. canal; thence Southwesterly parallel to and 100 ft. distant from the center line of said canal to a point 2270 ft. W. and 855 ft. N. of the NE corner of said Claim 38; thence S. 755 ft.; thence S. 36° 55' E. 100 ft. to a point 20 ft. N. of said Claim line; thence E. 1235 ft. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
