CERTIFICATE OF WATER RIGHT

This Is to Certify, That MILTON R. SCHWEPPE

of Tipton Road 480, Roseburg, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Umpqua River a tributary of _____ for the purpose of irrigation under Permit No. 24657 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 18, 1957.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.02 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ SW $\frac{1}{4}$ as projected within J. Kelly DLC #41, Section 25, Township 27 South, Range 6 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 0.8 acres in the NW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected within J. Kelly DLC #41
 - 1.0 acres in the SW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected within J. Kelly DLC #41
- Section 25
Township 27 South, Range 6 West, W.M.

Land on which water is to be used is part of that described as follows:

Beginning at a pipe on the Northwesterly right of way line of County Road #114 from which the Easterly corner of Lot 7, "The Oaks" Addition, Roseburg, Douglas Co., Oregon, bears N. 61° 00' E. 24.0 ft.; thence S. 61° 00' W. 192 ft. along the Northwesterly right of way line of County Road #114 to a pipe; thence N. 28° 45' W. 301.6 ft. to a pipe; thence on the same bearing 149.4 ft. to a pipe; thence 92 ft. + to the S. Umpqua River; thence in a Northeasterly direction along the S. Umpqua R. 116.0 ft. to a point; thence S. 28° 45' E. 91 ft. + to a pipe; thence on same bearing 276.7 ft. to a pipe; thence N. 61° 15' E. 76.0 ft.; thence S. 28° 45' E. 174.0 ft. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
