CERTIFICATE OF WATER RIGHT

This Is to Certify, That M. W. IRWIN

of Rt. 1, Box 167, Scio, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Thomas Creek a tributary of South Santiam River for the purpose of irrigation under Permit No. 20571 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 22, 1951.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.25 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ NE $\frac{1}{4}$ & SE $\frac{1}{4}$ NE $\frac{1}{4}$ both as projected within J. Thomas DLC #47, Section 9, Township 10 South, Range 1 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.2 acres in the SW $\frac{1}{4}$ NE $\frac{1}{4}$, as projected within J. Thomas DLC #47
 8.0 acres in the SE $\frac{1}{4}$ NE $\frac{1}{4}$, as projected within J. Thomas DLC #47
 8.8 acres in the NE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within J. Thomas DLC #47
 3.2 acres in the NW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within J. Thomas DLC #47
 Section 9
 Township 10 South, Range 1 West, W.M.

Land on which water is to be used is part of that described as follows:

Beginning at the SW corner of the DLC of Jesse B. Thomas, Notification No. 555, and Claim No. 47 in T. 10 S., R. 1 W., W.M., in Linn County, Oregon, and running thence E. 40 chs.; thence N. to the center of the main channel of Thomas Creek; thence W. down the center of the main channel of said Creek to the W. boundary line of said Jesse B. Thomas DLC; thence S. on said W. boundary line of said Claim 7 chs. and 50 links more or less, to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
