## CERTIFICATE OF WATER RIGHT

This Is to Certify, That JOHN W. and DORIS M. BAYLESS

of Box 172, Philomath, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Woods Creek a tributary of Marys River for the purpose of irrigation under Permit No. 20960 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 19, 1950,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.062 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$  SW $\frac{1}{4}$ , Section 4; NW $\frac{1}{4}$  NW $\frac{1}{4}$ , Section 9; both as projected within Jesse Wood DLC #75, Township 12 South, Range 6 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 2.63 acres in the NW $\frac{1}{4}$  NW $\frac{1}{4}$ , as projected within Jesse Wood DLC #75  
Section 9
- 2.50 acres in the SW $\frac{1}{4}$  SW $\frac{1}{4}$ , as projected within Jesse Wood DLC #75  
Section 4  
Township 12 South, Range 6 West, W.M.

Land on which water is to be used is part of that described as follows:

Beginning at the SE corner of the Jesse Wood DLC, it being Claim No. 25 in T. 12 S., R. 6 W., W.M.; thence W. along S. boundary line of said DLC No. 75, 2130 ft.; thence N. 751 ft. to the S. side of W. C. Noon Lumber Company's right of way; thence in a northeasterly direction along the S. and E. side of said W. C. Noon Lumber Company's right of way 1100 ft.; more or less, to the center of the county road running up Woods Creek; thence down the center of said county road 1587 ft., more or less, to the E. line of said DLC No. 75; thence S. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
