CERTIFICATE OF WATER RIGHT

This Is to Certify, That DARYL E. OTJEN

of Rt. 5, Box 95, Salem , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream & reservoir constructed under Appl. No. R-28168, Per. No. R-1486 a tributary of Pudding River for the purpose of irrigation & fire protection

under Permit No. 22167 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 3. 1953.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.07 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the $\frac{1}{2}$ Ne $\frac{1}{4}$ Ne $\frac{1}{4}$, Section 10, Township 8 South Range 2 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-1486.

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.6 acres & fire protection in the NE4 NE4 2.4 acres in the SE4 NE4 Section 10 Township 8 South, Range 2 West, W.M.

Land on which water is to be used is part of that described as follows:

Beginning at a point which is 2706.8 ft. N. 0° 14' E. & 1032.65 ft. N. 89° 40'
E. from SE corner of the Abram Olinger DLC #57 in T. 8 S., R. 2 W., W.M., Marion
Co., Ore., said point of beginning being on the N. line of a certain tract of
land conveyed to F. G. Huston by deed recorded April 30, 1947 in Vol. 368, Page 462,
deed records for said Co. & State; thence N. 89° 40' E. along the N. line of the
said Huston tract, and along said line extended Easterly 1073.31 ft. to the center
of a County road; thence N. 1° 03' W. along the center of the said County Road
808.15 ft. to an iron rod; thence N. 88° 58' W. 1055.29 ft.; thence S. 0° 14' W.
833.23 ft. to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
