**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That**      COQUILLE PLYWOOD, INC.

of Coquille, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Coquille River a tributary of Pacific Ocean for the purpose of maintenance of Log Pond No. 2 constructed under Appl. #R-29084, Per. #R-1631 under Permit No. 22978 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 15, 1954,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.0 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 8 (NW $\frac{1}{4}$  NW $\frac{1}{4}$ ), Section 2, Township 28 South, Range 13 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to - - - - - of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

SW $\frac{1}{4}$  SE $\frac{1}{4}$   
Section 35  
Township 27 South, Range 13 West, W.M.  
Lot 6 (NW $\frac{1}{4}$  NE $\frac{1}{4}$ )  
Section 2  
Township 28 South, Range 13 West, W.M.

The description of the Pond Area is described as follows to-wit: Beginning at an iron pipe at the SE cor. SW $\frac{1}{4}$  SE $\frac{1}{4}$ ; thence N. 1184.0 ft. more or less to foot of hill; thence S. 86° 00' W. 100.0 ft. along foot of hill; thence N. 83° 27' W. 170.0 ft. more or less; thence N. 83° 27' W. 203.5 ft.; thence N. 112.0 ft. more or less to the S. boundary of Hwy. No. 101; thence westerly along S. boundary of said Hwy. 245.0 ft. more or less to the E. boundary of a logging road; thence S. 34° 35' W. along the E. boundary of said road and pond dike a distance of 1850.0 ft. more or less to the N. boundary of the SPRR R/W; thence easterly along said RR R/W 1000.0 ft. more or less to a point 537.9 ft. S. of the place of beginning; thence N. 737.9 ft. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
