**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** BURTON A. MYERS, M. D.

of 495 Riggs St., Salem, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rickreall Creek a tributary of Willamette River for the purpose of irrigation under Permit No. 19906 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 22, 1950,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.20 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$  SE $\frac{1}{4}$  as projected within Joshua Shaw DLC #60, Section 26, Township 7 South, Range 4 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 0.4 acres in the NW $\frac{1}{4}$  SE $\frac{1}{4}$ , as projected within Joshua Shaw DLC #60
- 12.9 acres in the SW $\frac{1}{4}$  SE $\frac{1}{4}$ , as projected within Joshua Shaw DLC #60  
Section 26
- 3.0 acres in the NW $\frac{1}{4}$  NE $\frac{1}{4}$ , as projected within Joshua Shaw DLC #60  
Section 35

Township 7 South, Range 4 West, W.M.

Land on which water is to be used is part of that described as follows:

From a point on La Creole Creek where the same borders or touches the following described property, to-wit:

Beginning at a point on the W. boundary of the Joshua Shaw land claim, 7.905 chs. S. of NW corner thereof, running S. 77° E. 3.14 chs. along center of the Salem-Dallas County Road to an angle; thence S. 89° 54' E. 5.05 chs. along the center of said road; thence S. 0° 15' W. 25.63 chs. to middle of La Creole Cr.; thence following the meanders of the middle line of said stream to the point where the same is intersected by the W. line of the Joshua Shaw DLC. Thence N. 22.04 chs. along W. line of Joshua Shaw DLC to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
