CERTIFICATE OF WATER RIGHT

This Is to Certify, That JOHN KUSCHNICK

of Rt. 1, Gervais , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream a tributary of Pudding River for the purpose of irrigation under Permit No. 21252 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 16, 1951,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.33 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ SW $\frac{1}{4}$, SE $\frac{1}{4}$ SW $\frac{1}{4}$, both as projected within Felix Coonse DLC #56, Section 31, Township 5 South, Range 1 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.4 acres in the SW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within Coonse DLC #56
10.0 acres in the SW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected within Coonse DLC #56
8.8 acres in the SE $\frac{1}{4}$ SW $\frac{1}{4}$, as projected within Coonse DLC #56

Section 31

Township 5 South, Range 1 West, W.M.

0.6 acres in the NE $\frac{1}{4}$ NW $\frac{1}{4}$, as projected within Coonse DLC #62
6.8 acres in the NW $\frac{1}{4}$ NW $\frac{1}{4}$, as projected within Coonse DLC #62

Section 6

Township 6 South, Range 1 West, W.M.

Land on which water is to be used is part of that described as follows:

Beginning at a point on the W. boundary of the Felix Coonse and wife DLC, 36.22 chs. N. of the SW corner of said claim; thence N. 10.65 chs.; thence E. 61.60 chs.; thence S. 10.65 chs.; thence W. 61.60 chs. to the place of beginning and being part of the DLC of Felix Coonse and wife, Secs. 5 & 6, T. 6 S., R. 1 W., W.M., and Secs. 31 & 32, T. 5 S., R. 1 W., W.M., in Marion County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
