## CERTIFICATE OF WATER RIGHT

**This Is To Certify, That** M. B. EMMITT and H. B. KRUSE

of Rt. 2, Box 605, Roseburg, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Umpqua River a tributary of Umpqua River for the purpose of irrigation under Permit No. 21379 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 12, 1952,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.66 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 10 (SE $\frac{1}{4}$  SE $\frac{1}{4}$ ), Section 32, Township 26 South, Range 6 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 1.6 acres in the NW $\frac{1}{4}$  SE $\frac{1}{4}$ , as projected within O. T. Williams DLC #55
  - 31.7 acres in the NE $\frac{1}{4}$  SE $\frac{1}{4}$ , as projected within O. T. Williams DLC #55
  - 5.2 acres in the SE $\frac{1}{4}$  SE $\frac{1}{4}$ , as projected within O. T. Williams DLC #55
  - 0.2 acres in Lot 10 (SE $\frac{1}{4}$  SE $\frac{1}{4}$ )  
Section 32
  - 10.0 acres in the NW $\frac{1}{4}$  SW $\frac{1}{4}$ , as projected within O. T. Williams DLC #55
  - 0.3 acres in Lot 13 (NW $\frac{1}{4}$  SW $\frac{1}{4}$ )
  - 3.4 acres in the SW $\frac{1}{4}$  SW $\frac{1}{4}$ , as projected within O. T. Williams DLC #55
  - 0.2 acres in Lot 9 (SW $\frac{1}{4}$  SW $\frac{1}{4}$ )  
Section 33

Land on which water is to be used is part of that described as follows:

M. B. Emmitt: Beginning at the NE corner of the tract or parcel of land conveyed to L. F. Meyers by J. F. and Mildred H. Bonebrake as recorded in Vol. 93, Page 581 of the deed records of Douglas Co., Oregon, said beginning point being S. 70° 13' E. 4549.0 ft. and N. 78° 54' E. 1331.4 ft. from the  $\frac{1}{4}$  Sec. corner between Secs. 31 and 32, T. 26 S., R. 6 W., W.M. Thence S. 13° 24' E. 782.2 ft. along the E. boundary of said tract of land to the SE corner thereof; thence S. 87° 10' W. 108.0 ft. S. 69° 48' W. 149.2 ft., S. 78° 40' W. 152.2 ft. and S. 68° 13' W. 119.6 ft. along the southerly of river boundary of said tract. Thence N. 22° 00' W., 810.1 ft. to a point in the northerly boundary of said tract. Thence N. 78° 54' E. 567.0 ft. along said northerly boundary to the place

of beginning, containing 8.87 acres more or less, being the easterly part of the tract noted above as recorded in Vol. 93, Page 581, of the deed records of Douglas County, Oregon.
