a tributary of Willamette River

for the purpose of

irrigation

under Permit No. 22067 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 30, 1953.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.22 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 3 (NE_{+}^{1} SW_{+}^{1}), Section 15. Township 20 South, Range 3 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year.

Beginning at a point 558.6 ft. N. 89° 37' W. of a point on the E. line of the Hiram Coverdill DIC #52 in T. 20 S., R. 3 W., W.M., which is 1032.0 ft. N. 0° 11' E. from the SE corner thereof and running thence N. 0° 11' E. 156.3 ft., thence N. 89° 57' 30" W. 1788.5 ft. to the right bank of the Coast Fork Willamette River, thence upstream along said River bank S. 10° 15' 30" E. 773.5 ft., thence S. 89° 57' 30" E. 1649.0 ft., thence N. 0° 07' E. 605.00 ft. to the place of beginning.
