## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That THOMAS H. HUBBARD

of Rt. 4. Box 1380. Roseburg , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream

a tributary of Lookingglass Creek

for the purpose of

irrigation

under Permit No. 22251 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 9, 1953.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.06 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the  $NW_{\overline{u}}^{1}$   $NE_{\overline{u}}^{1}$  as projected within S. Martin DLC #56. Section 36. Township 27 South, Range 7 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year.

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.6 acres in the  $SW_{+}^{1}$   $SE_{+}^{1}$  0.2 acres in the  $SE_{+}^{1}$   $SE_{+}^{2}$ 

Section 25 2.8 acres in the  $NW_{+}^{1} NE_{+}^{1}$

All as projected within S. Martin DLC #56 Township 27 South, Range 7 West. W.M.

Land on which water is to be used is part of that described as follows: That land lying N. of an unnamed stream in the  $\mathbb{E}_{2}^{\perp}$  of the following described parcel: Beginning at the SW corner of the S. H. Martin DIC #56, thence N. to a point in the center of the Coos Bay Wagon Road, thence following said road to a point on the E. side of said claim, thence S. to the SE corner of claim 56, thence W. to place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
