CERTIFICATE OF WATER RIGHT

This Is to Certify, That GEORGE M. KRANTZ

of Rt. 1, Scio, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of unnamed stream, spring & reservoir constructed under Appl. #R-26017, Per. #R-1219 a tributary of Neal Creek for the purpose of irrigation and domestic use, 1 family under Permit No. 20557 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 8, 1951.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.14 cubic foot per second, being 0.13 cubic foot per second from stream and reservoir for irrigation and 0.01 cubic foot per second from spring for domestic,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ NE $\frac{1}{4}$, SE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 10; SW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 11, Township 10 South, Range 1 East, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-1219,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows: 3.8 acres in Lot 1 (SE $\frac{1}{4}$ NE $\frac{1}{4}$)

Section 10
domestic in the NW $\frac{1}{4}$ NW $\frac{1}{4}$, as projected within J. Logan DLC #48
6.8 acres in the SW $\frac{1}{4}$ NW $\frac{1}{4}$, as projected within J. Logan DLC #48
Section 11

Township 10 South, Range 1 East, W.M.

Land on which water is to be used is part of that described as follows:

Beginning at a point on the N. boundary line of Logan DLC #48, T. 10 S., R. 1 E., W.M., 90 rods E. of the NW corner of said DLC; thence S. 40 chs. to the S. boundary line of said Logan DLC; thence E. along the S. boundary of said Logan DLC to the NW corner of Lot 1, Sec. 10, T. 10 S., R. 1 E., W.M.; thence S. along the W. line of said Lot 1 to the N. line of the third tract conveyed to Mary Koberlein; thence E. along said N. line to the E. line of said Lot 1; thence N. along said E. line of said Lot 1 to the NE corner thereof; thence E. 70 rods to a point on the S. line of Logan DLC #48, 58 chs. E. of the SW corner of said Logan DLC; thence N. 40 chs. to the N. boundary line of said DLC #48; thence W. along the N. boundary line of said DLC 35.50 chs. to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
