## CERTIFICATE OF WATER RIGHT

This Is To Certify, That F. MILES MAYFIELD

of Post ,State of Oregon ,has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Fork Crooked River, Stewart Creek, Sarvis Creek & 2 reservoirs constructed under Appl. No. R-24576, Per. No. R-1422 & Appl. No. R-24577, Per No. R-1423 of Crooked River

irrigation & supplemental irrigation under Permit No. 21721 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Gregon; that the priority of the right hereby confirmed dates from April 5, 1950.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.81-cubic feet per second, being 1.21 cubic feet per second from Crooked River, and 0.50 cubic foot per second from Sarvis Creek, and 0.10 cubic foot per second from Stewart Creek and reservoirs,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the  $SW_{4}^{\frac{1}{4}}$ ,  $SE_{4}^{\frac{1}{4}}$ ,  $NE_{4}^{\frac{1}{4}}$ ,  $NE_{4}^{\frac{1}{4}}$ ,  $NE_{4}^{\frac{1}{4}}$ ,  $SE_{4}^{\frac{1}{4}}$ ,  $NE_{4}^{\frac{1}{4}}$ ,  $NE_{4}^{\frac{1}$ 

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 4 acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permits Nos. R-1422 and R-1423.
