February 13, 1951, confirmed dates from

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.42 cubic foot per second, being 0.30 cubic foot per second from Elk Creek and 0.12 cubic foot per second from Parker Creek,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the $S^{k_4^2}$, SE^k_4 , Section 8 and NW^k_4 , NE^k_4 , Section 17, both as projected within Daisley DIC #37; Township 22 South, Range 6 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year.

conform to such reasonable rotation system as may be ordered by the proper state officer.
