CERTIFICATE OF WATER RIGHT

This Is to Certify, That J. RICHARD GUERBER

of Rt. 3, Box 605, Corvallis, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Winkle Lake and Whittaker Lake a tributary of _____ for the purpose of irrigation under Permit No. 21557 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 26, 1952.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.12 cubic feet per second, being 0.56 cubic foot per second from Winkle Lake and 0.56 cubic foot per second from Whittaker Lake,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 14 and NE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 23 both as projected within Isaac Winkle DLC #47, Township 13 South, Range 5 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

27.2 acres in the NE $\frac{1}{4}$ SW $\frac{1}{4}$
37.8 acres in the SE $\frac{1}{4}$ SW $\frac{1}{4}$
0.7 acres in the NE $\frac{1}{4}$ SE $\frac{1}{4}$
33.8 acres in the NW $\frac{1}{4}$ SE $\frac{1}{4}$
18.7 acres in the SW $\frac{1}{4}$ SE $\frac{1}{4}$
Section 14
2.4 acres in the NE $\frac{1}{4}$ NW $\frac{1}{4}$
Section 23
Township 13 South, Range 5 West, W.M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
