CERTIFICATE OF WATER RIGHT

This Is to Certify, That WILLIAM T. SCHULZ

of Rt. 1, Box 315-R, Eagle Point, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rogue River a tributary of Pacific Ocean for the purpose of irrigation under Permit No. 24943 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 24, 1957.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.04 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$, SW $\frac{1}{4}$, Section 33, Township 34 South, Range 1 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.6 acres in the SE $\frac{1}{4}$ SE $\frac{1}{4}$
Section 32
1.4 acres in the SW $\frac{1}{4}$ SW $\frac{1}{4}$
Section 33
Township 34 South, Range 1 West, W.M.

Land on which water is to be used is part of that described as follows:

Commencing at a point 2206.57 ft. S. & 421.24 ft. E. of the NW corner of Lot 2 & being located on the easterly right of way boundary of the County Road; thence along said easterly road boundary S. 14° 07' W. 298.71 ft.; thence continuing S. 14° 07' W. along said road boundary 1117.0 ft. to the true point of beginning; thence S. 88° 38' E. 1525.42 ft. to intersect the W. bank of the Rogue River; thence along said W. bank N. 1° 45' E. 218.97 ft.; thence N. 89° 03' W. 1478.97 ft. to the easterly right of way line of said County Road; thence along the road line S. 14° 07' W. 217.0 ft. to the true point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
