to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of

a well

a tributary of Umatilla River

for the purpose of

irrigation of 11.9 acres

under Permit No. U-668 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 16, 1954,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.15 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW_+^1 NE_+^1 , Section 8, Township 2 North, Range 33 East, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

11.9 acres SW4 NE4

Section 8
Township 2 North, Range 33 East, W.M.

Land on which water is to be used is part of that described as follows:

Commencing at a point on the S. line of the SW¹/₄ NE¹/₄ of Sec. 8. T. 2 N., R. 33 E.,
W.M., 149 ft. W. of the SE corner of said SW¹/₇ NE¹/₄, said point also being the SW
corner of that tract of land corveyed to Wm. Purchase, et ux, thence W. along the
S. line of said SW¹/₇ NE¹/₄, 481.4 ft. to the SE corner of that tract of land conveyed
to John M. Carroll, et ux, thence X. along the E. line of said Carroll tract
1044.8 ft. to the southerly right of way line of the Old Oregon Trail Highway, as
the same now exists; thence easterly, along the said southerly right of way line,
to a point which is 149 ft. distant from, when measured at right angles to, the
E. line of said SW¹/₇ NE¹/₄, said point also being the NW corner of the aforesaid
Purchase tract; thence S., parallel with the E. line of said SW¹/₄ NE¹/₄, and along
the W. line of said Purchase tract, to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
