## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That CHET HEALY

, State of Oregon 813 Main St., Dallas , has made proof to the satisfaction of the STATE ENGINEER of Oregon, if a right to the use of the waters of Little Luckiamute River

a tributary of Luckiamute River

for the purpose of

irrigation of 80.0 acres

of the State Engineer, and that said right to the use of said waters under Permit No. 18407 has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 16, 1948,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.27 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW: SE; as projected within Bowman DIC #51. Section 7, Township 9 South, Range 5 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shill be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year.

conform to such reasonable rotation system as may be ordered by the proper state officer.

32.3 acres SE4 SE4, as projected within David Lewis DLC #55 Section 7

0.9 acres NW4 SW4, as projected within S. A. Bowman DIC #51 0.8 acres Lot 1 (NW SW)
