CERTIFICATE OF WATER RIGHT

This Is to Certify, That MARVIN R. MAY

of Rt. 1, Box 256-A, Dallas, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream a tributary of Salt Creek for the purpose of irrigation of 6.2 acres under Permit No. 22575 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 30, 1953.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.03 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 3 (NW $\frac{1}{4}$ NE $\frac{1}{4}$), Section 7, Township 7 South, Range 5 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

6.2 acres Lot 3 (NW $\frac{1}{4}$ NE $\frac{1}{4}$)
Section 7
Township 7 South, Range 5 West, W.M.

Land on which water is to be used is part of that described as follows:

Beginning at an iron pipe 2046 ft. W and 33 ft. S from SE corner of the Fredrick DLC #38; thence S 2° 22' W 142.2 ft. to an I.P.; thence S 31° 27' W 429.0 ft. to an I.P.; thence S 39° 19' W 320.1 ft. to an I.P.; thence W 108.9 ft. to an I.P.; thence S 20° 18' W 445.2 ft. to an I.P.; thence W 308.6 ft. to an I.P.; thence N 0° 36' E 777.2 ft. to an I.P. at the SW corner of a tract heretofore conveyed by grantors to grantees by deed recorded on page 272, book 81, record of deeds, thence E 547.3 ft. to an I.P.; thence N 14° 16' E 413.0 ft. to an I.P., on the S side of the road at the NE corner of the above described tract; thence E 343.2 ft. to the place of beginning. Also beginning at a point which is 2389 ft. W and 33 ft. S of SE corner of Fredrick and wife DLC #38; thence S 14° 06' W 410 ft. to an I.P.; thence W 548 ft. to an I.P.; thence N 400 ft. to an I.P., thence E 647 ft. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
