CERTIFICATE OF WATER RIGHT

(For rights perfected under original or secondary permits)

THIS IS TO CERTIFY, That LOWER HUDSON BAY IRRIGATION COMPANY of Freewater, State of Oregon, has made proof to the satisfaction of the STATE WATER BORD of Oregon, of a right to the use of the waters of Swartz Spring Creek, a tributary of Pine Creek, for the purpose of the irrigation of 440 acres of land under Permit No. 519 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon and duly confirmed by order of the STATE WATER BORD of Oregon, made and entered of record in the Record of Proceedings of said Board, at Salem, in Volume 1, at Page 340, on the 19th day of November, 1919; that the priority of the right hereby confirmed dates from November 26, 1910; that the amount of water to which such right is entitled and herebyconfirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 5.5 cubic feet per second, or its equivalent in case of rotation. The use hereunder shall conform to any reasonable rotation system ordered by the proper State Officer.

A description of the lands under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to

beneficial use, is as follows: 20 acres in the Southeast quarter of Southeast quarter; 40 acres in the Northwest quarter of the Southeast quarter; (5 acres in the Southwest of the Southeast quarter;) 2 acres in the Southwest quarter of Northeast quarter; 15 acres in the Southeast quarter of Southwest quarter; 40 acres in the Northeast quarter of Southwest quarter; 10 acres in the Southwest quarter of Southwest quarter; 20 acres in the Northwest quarter of Southwest quarter; 20 acres in the Southeast quarter of Northwest quarter and 10 acres in the Southwest quarter of Northwest quarter of Section Fifteen: 30 acres in the Northeast quarter of Southeast quarter; 20 acres in the Southeast quarter of Northeast quarter of Northeast quarter of Section Sixteen; 40 acres in the Southeast quarter of Southwest quarter; 30 acres in the Southwest quarter of Southwest quarter and 15 acres in the Northeast quarter of Northeast quarter of Section Twenty-two: 25 acres in the Northeast quarter of Southeast quarter; 30 acres in the Southeast quarter of Northeast quarter and 15 acres in the Southwest quarter of Northeast quar ter of Section Twenty-one and 20 acres in the Northwest quarter of Northwest quarter of Section Twenty-three, Township Six North, Range Thirty-four East of Willamette Meridian, in Umatilla County, Oregon.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.

Rights to the use of water for power purposes are limited to a period of forty years from the date of priority of the right, as herein set forth, subject to a preference right of renewal under the laws existing at the date of the expiration of the right for power purposes, as hereby confirmed and limited.
