CERTIFICATE OF WATER RIGHT

(For rights perfected under original or secondary permits)

THIS IS TO CERTIFY, That MOUNTAIN SHEEP DITCH COMPANY, a corporation of Joseph, State of Oregon, has made proof to the satisfaction of the STATE WATER BOARD of Oregon, of a right to the use of the waters of Little Sheep Ditch and Mountain Sheep Reservoir, a tributary of water to be stored under Reservoir Permit No. 223, for the purpose of supplemental supply for the irrigation of 1484 acres of land under Permit No. 1448 of the StateEngineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon and duly confirmed by order of the STATE WATER BOARD of Oregon, made and entered of record in the Record of Proceedings of said Board, at Salem, in Volume 1, at page 340, on the 19th day of November, 1919; that the priority of the right hereby confirmed dates from January 18, 1913,; that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 18.55 cubic feet per second, or its equivalent in case of rotation. The use hereunder shall conform to any reasonable rotation system ordered by the proper State Officer.

Rights to the use of water for power purposes are limited to a period of forty years from the date of priority of the right, as herein set forth, subject to a preference right of renewal under the laws existing at the date of the expiration of the right for for power purposes, as hereby confirmed and limited.
