CERTIFICATE OF WATER RIGHT

This Is to Certify, That CARL and VIOLA INEZ MAY

of 638 Washington Street, Dallas, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rickreall Creek a tributary of Willamette River for the purpose of irrigation of 5.1 acres under Permit No. 21727 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 8, 1952.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.06 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ NW $\frac{1}{4}$ as projected within Isaac Levens DLC #51, Section 32, Township 7 South, Range 5 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year.

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5.1 acres SW $\frac{1}{4}$ NW $\frac{1}{4}$, as projected within Isaac Levens DLC #51
Section 32
Township 7 South, Range 5 West, W.M.

Land on which water is to be used is part of that described as follows:

Beginning at the SE corner of the Benjamin Nichols DLC #69, in T. 7 S., R. 5 W., W.M. in Polk County, Oregon, and running thence S. 0° 2 $\frac{1}{2}$ ' W. 30.0 ft. to an iron pipe; thence N. 89° 51 $\frac{1}{2}$ ' W. 921.75 ft. to an iron pipe; thence S. 0° 2 $\frac{1}{2}$ ' W. 1199.64 ft. to a point on the N. bank of the LaCreole Creek; thence N. 45° 8' W. 808.9 ft. to a point on said bank; thence N. 14° W. 230.0 ft. to a point on said bank; thence N. 24° 14' E. 477.7 ft. to a point on said bank from which an iron pipe bears S. 89° 51 $\frac{1}{2}$ ' E. 57.1 ft.; thence S. 89° 51 $\frac{1}{2}$ ' E. 1357.1 ft. along the S. line of said Nichols DLC to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
