**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** E. J. SCHUERCH

of Rt. 1, Box 162, Willamina, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Yamhill River a tributary of Willamette River for the purpose of irrigation of 39.0 acres under Permit No. 22103 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 13, 1952,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.30 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$  NE $\frac{1}{4}$  as projected within Kuykendall DLC #57, Section 18, Township 6 South, Range 7 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

All as projected within Kuykendall DLC #57

Land on which water is to be used is part of that described as follows:

Beginning at a post on the N. boundary of & being N. 66° 45' E. 938.5 ft. from the NW corner of the Kuykendall DLC #57, T. 6 S., R. 7 W., W.M.; thence S. 19° E. 5640 ft. to an iron pipe on the S. boundary of said claim; thence N. 54° 30' E. on S. boundary of claim 863 ft. to an iron pipe; thence N. 17° 15' W. 5457 ft. to the N. boundary of said claim; thence S. 66° 45' W. along N. boundary of said claim 988 ft. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
