of RFD #1. Box 215, Silverton , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream

a tributary of Abiqua River

for the purpose of

irrigation of 13.2 acres

under Permit No. 22455 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 29, 1953.

that the amount of water to which such right is entitled and hereby confirmed, for the urposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.12 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW_4^1 SE_4^{11} of Section 26, NW_4^1 NE_4^{11} of Section 35 both as projected within Brown DLC #47. Township 6 South, Range 1 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

8.8 acres SW¹₄ SE¹₅, as projected within Brown DLC #47 Section 26 4.4 acres iW¹₄ NE¹₄, as projected within Brown DLC #47 Section 35 Township 6 South, Range 1 West, W.M.

Land on which water is to be used is part of that described as follows:

Commencing at a point in the County Road leading from Silverton to Scotts Mills, said commencing point being the SW corner of a 20.00 acre tract of land conveyed by C. F. DeGuire and wife and M. E. DeGuire and wife to E. N. Erickson and wife; thence S. 63° 30° W. 6.11 chs.; thence N. 6° E. 27.90 chs.; thence N. 70° 45′ E. 5.83 chs. to the NW corner of the said Erickson's 20.00 acre tract of land; thence S. 6° W. 27.01 chs. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
