CERTIFICATE OF WATER RIGHT

This Is To Certify, That MR. & MRS. R. C. LYNN & MARTIN STADELMAN

of Cornelius, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of East Dairy Creek a tributary of Tualatin River for the purpose of irrigation under Permit No. 19060 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 6, 1949

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.31 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 15, Township 2 North, Range 3 West, W. M., for the irrigation of the Stadelman lands and in the NW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 22, Township 2 North, Range 3 West, W. M., for the irrigation of the Lynn lands.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Lands owned by Martin Stadelman

11.6 acres in the NE $\frac{1}{4}$ NW $\frac{1}{4}$
4.09 acres in the NW $\frac{1}{4}$ NW $\frac{1}{4}$
Section 22,
Township 2 North, Range 3 West, W. M.,
lying east of County Road No. 12

Lands owned by Mr. & Mrs. R. C. Lynn

9.31 acres in the NW $\frac{1}{4}$ NW $\frac{1}{4}$
Section 22,
Township 2 North, Range 3 West, W. M.,
lying west of County Road No. 12

All of the land above described on which water is used is part of that described as follows:

Commencing 15.68 chains West of the Northeast corner of the NW $\frac{1}{4}$ of Section 22, Township 2 North, Range 3 West, W. M., thence South 18° 8' East 14.50 chains to a ditch; thence down said ditch to where it crosses the North line of the SE $\frac{1}{4}$ NW $\frac{1}{4}$, said Section 22; thence West 23.0 chains to the section line; thence North 20.0 chains to the Northwest corner of said section; thence East on said section line 24.32 chains to the place of beginning.

NOTE: This certificate is issued to confirm a change in point of diversion of water approved by an Order of the State Engineer entered January 22, 1958, pursuant to the provisions of ORS 540.510 to 540.530, and supersedes certificate of water right heretofore issued to Mr. and Mrs. R. C. Lynn and recorded at Page 23444, Volume 16, State Record of Water Right Certificates.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
