an unnamed stream, a tributary of Class Clackamas River

for the purpose of

irrigation under Permit No. 15303 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 24, 1942

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

0.04 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 5 (Sw1 NE1), Section 29, Township 3 South, Range 4 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, ar 1 to which such right is appurtenant, is as follows:

> 3 acres in Lot 5 (SW: NE+) Section 29, Township 3 South, Range 4 East, W. M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

Part of Gov. Lot 5 in Section 29, in T. 3 S., R. 4 E. of W. M. Beginning at the Northwest corner of the Northeast Quarter of the Southeast Quarter of Section 29, in T. 3 S., R. 4 E. W. M., thence South 89° 56' West on quarter section line 10.50 chains to the Southeast corner of land owned by Oral Stormer, and wife; thence North 3.46 chains more or less to county road, thence 87° 40' Fast in said road 10.50 chains, more or less, to east line of said Gov. Lot 5; thence South on lot line 3.69 chains more or less, to the place of beginning, containing 3 acres more or less.

This certificate is issued to confirm a change in point of diversion NOTE: of water approved by an Order of the State Engineer entered August 14, 1956, pursuant to the provisions of ORS 540.510 to 540.530, and supersedes certificate of water right heretofore issued to Harry L. and Everett E. Osborne and recorded at Page 15481, Volume 13, State Record of Water Right Certificates.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
