and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Baker County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 6, at page 291; that the priority of the right thereby confirmed dates from 1879 for 71 acres; 1885 for 80 acres; and 1888 for 10 acres;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed one-fortieth of one cubic foot per second per acre, and shall be subject to all other conditions and limitations contained in said decree.
