0regon 97754 State of , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Horse Heaven Creek & reservoir constructed under Appl. No. R-24957, Per. No. R-1130 a tributary of Crooked River for the purpose of primary irrigation of 73.4 acres from natural flow of Horse Heaven Creek and storage; supplemental irrigation of 106.2 acres from storage only under Permit No. 20200 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 2, 1951.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 4.49 cubic feet per second, and shall be further limited to a diversion of 1.83 cubic feet per second from direct flow of Horse Heaven Creek,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the $NE_4^{\frac{1}{4}}$ $NW_4^{\frac{1}{4}}$ & $SW_4^{\frac{1}{4}}$ $NW_4^{\frac{1}{4}}$ of Section 16, $SE_4^{\frac{1}{4}}$ $SW_4^{\frac{1}{4}}$ of Section 17, $NE_4^{\frac{1}{4}}$ $NE_4^{\frac{1}{4}}$ of Section 19, Township 16 South, Range 19 East, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second peracre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 4 acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-1130,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
