CERTIFICATE OF WATER RIGHT

This Is to Certify, That CHESTER W. and GLADYS H. BEDORTHA

of Rt. 2, Box 620, Creswell, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rattlesnake Creek a tributary of Middle Fork Willamette River for the purpose of irrigation of 12.0 acres under Permit No. 17943 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 22, 1947.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.14 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ NW $\frac{1}{4}$ as projected within Bristow DLC #67, Section 36, Township 18 South, Range 2 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.8 acres SW $\frac{1}{4}$ SW $\frac{1}{4}$

6.2 acres SE $\frac{1}{4}$ SW $\frac{1}{4}$

Section 25

1.4 acres NW $\frac{1}{4}$ NW $\frac{1}{4}$

2.6 acres NE $\frac{1}{4}$ NW $\frac{1}{4}$

Section 36

All as projected within Bristow DLC #67
Township 18 South, Range 2 West, W.M.

Land on which water is to be used is part of that described as follows:

Commencing at a point 383.81 ft. S. 89° 25' E. of a point which is 39.78 chs. S. of a point 32.36 chs. E. of the NW corner of Bristow and wife DLC #67 in T. 18 S., R. 2 W., W.M., Noti. #7045, and running thence E. 435.25 ft.; thence N. 351.12 ft.; thence E. 993.96 ft.; thence N. 2194.50 ft.; thence W. 1094.94 ft.; thence S. 530.64 ft.; thence W. 718.08 ft. to the center line of a County Road; thence S. along the center line of said road, 602.23 ft.; thence S. 89° 53' E. 54.5 ft.; thence S. 0° 07' W. 75.0 ft.; thence N. 89° 53' W. 30.96 ft.; thence S. 14° 57' E. 1385.41 ft. to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
