of Route 2, Box 25, Salem , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a well

a tributary of Willamette River

for the purpose of

irrigation of 5 acres

under Permit No. G-400 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 7, 1956.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.06 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW_{+}^{1} NE_{+}^{1} . Section 33, Township 6 South, Range 3 West, W.M. 705 ft. E. and 165 ft. South from NE_{+}^{2} corner Section 33,

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5 acres NW4 NE4 Section 33 Township 6 South, Range 3 West, W.M.

Land on which water is to be used is part of that described as follows:

Beg. on the N. line of Sec. 33, T. 6 S., R. 3 W., W.M., in Marion County, Ore.;
at a point which is 10.680 chs. S. 89°32' E. from the ½ cor. on the N. line of said
Sec.; th. S. 89°32' E. along the N. line of said Sec., 3.00 chs.; thence S. 0°12'
W. 16.880 chs.; thence N. 89°50' W. 2.470 chs. to the Easterly line of a tract of
land conveyed to William L. Wiederkehr by deed recorded in Vol. 360 Pg. 358,
Marion County Records; thence N. 0°10' E. along said Easterly line 0.755 chs.; th.
N. 57°01' W. along said Easterly line 0.631 chs.; thence N. 0°12' E. 15.798 chs.
to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
